

Private Property Pesticide By-laws In Canada

Population Statistics by Municipality

The lack of adequate protection from unwanted exposure to lawn pesticides at the federal and provincial level has fueled a growing surge in municipal pesticide ordinances designed to enhance the protection of public health and the environment. **The increase in municipal by-laws within Canada currently stands at 129.** An additional 13 pesticide by-laws are at the draft stage pending adoption.

Municipalities of all sizes have passed various forms of pesticide by-laws. The largest is the *City of Toronto* with a population of 2.5 million while some are as small as *Sainte-Paule, Québec* with a population of 229.

There are over 12.8 million Canadians, or 40.56% of Canada's total population (based on the 2006 Census), benefiting from enhanced protection from unwanted exposure to synthetic lawn and garden pesticides. This figure includes the enhanced province-wide protection provided under Québec's Pesticide Management Code. There are 1141 municipalities (cities, villages and townships) within Québec.
